1.7 Programme summary

Epilepsy12 was established in 2009 and has the continued aim of helping epilepsy services, and those who commission health services, to measure and improve the quality of care for children and young people with seizures and epilepsies. The audit is commissioned by the Healthcare Quality Improvement Partnership (HQIP) as part of the National Clinical Audit and Patient Outcomes Programme (NCAPOP) and is delivered by the Royal College of Paediatrics and Child Health (RCPCH).

The audit collects and processes patient data to highlight the strengths of epilepsy services and identify areas for improvement. Epilepsy12 has two distinct workstreams; the clinical audit and the organisational audit. The annual report describes the care provided to children and young people with a new diagnosis of epilepsy (clinical audit) and the services and workforces of paediatric services at a Trust and Health Board level (organisational audit).

2.3 Governance arrangements

The audit is governed by a Project Board, which meets four times a year. The Board is chaired by the RCPCH Vice President, Science and Research, and includes the organisations and individuals listed on the organogram (see section 3.1)

The Board is responsible for overseeing the audit and providing oversight and advice to the programme. The Board is the guarantor of the data from the audit and is responsible for signing off the annual report. Overall clinical accountability is provided by the Vice President, Science and Research. Overall organisational and contractual accountability is provided by the Head of Audits, RCPCH. Additionally, representatives from HQIP and NHSE England are members of the Board, and a Welsh Government representative will be invited once identified.

The Project Team reports to the Project Board and is responsible for delivering the audit.

2.4 Stakeholder engagement

Representatives of two epilepsy charities, Epilepsy Action and Young Epilepsy sit on the Epilepsy12 Project Board and Methodology and Dataset Group. They are involved in:

- · Developing and approving audit measures
- · Setting priorities and strategic objectives
- · Developing communication strategy
- · Selecting key findings and developing recommendations
- · Communicating with audit participant units via meetings
- · Governance, risk and issue management

- Designing the children, young people and families national report summary booklet
- · Designing infographics

Children and young people are closely involved in Epilepsy12 as part of the Children and Young People Engagement Plan activities which are coordinated by the RCPCH Children and Young People's Engagement Team (RCPCH &Us) in conjunction with Epilepsy12 Youth Advocates.

Representatives from the paediatric epilepsy community and regional paediatric epilepsy networks are members of the Project Board and Methodology and Dataset Group. They are involved in:

- · Developing and approving audit measures
- Developing audit methodology
- Setting priorities and strategic objectives
- · Developing communication strategy
- Selecting key findings and developing recommendations
- Communicating with audit participant units via stakeholder events and meetings
- · Governance, risk and issue management

Audit participants are involved by:

- Providing feedback via an annual user feedback survey which seeks feedback on various aspects of the audit.
- Attending, presenting and providing feedback at national and regional stakeholder events
- Using, and providing feedback on the data platform and live performance indicator reports designed to ensure data quality and completeness via a user Focus Group.

2.5 Conflict of interest policy

Members of the Project Board have completed a declaration of interests, as part of the RCPCH register of interests process. A standing item is included on the Project Board agenda notifying members of their responsibility to ensure that their declaration is up to date.

3.1 Quality improvement goals

The Epilepsy12 quality improvement objectives are to:

- Increase rates of compliance with guidelines and standards of care in relation to the Epilepsy12 audit measures to improve outcomes for children and young people with epilepsies.
- Identify Health Boards/Trusts who are positive and negative outliers on these metrics to support local, regional paediatric epilepsy network and national level improvement.
- Share best practice through dissemination and promotion of case studies, delivery of national and regional stakeholder meetings.
- Deliver and evaluate further rounds of the Epilepsy12/OPEN UK-led Epilepsy Quality Improvement Programme before the end of the current round 4 contract end in March 2025.

Round 4 Overarching quality improvement objectives are to:

 assess whether those admitted to epilepsy services receive high quality care when measured against adherence to agreed guidance and standards National Clinical Audit of Seizures and Epilepsies for Children and Young People

- ensure clear % outcomes are agreed for all process measures
- identify areas for action through facilitation and stimulation of quality improvement in relation to delivery and outcomes of care
- relation to delivery and outcomes of care
- reduce unit and network level variation through benchmarking of outcome measures
- measure health inequality in relation to impact on the specified measures
- · report outlier identification and management using the appropriate guidance
- share best practice and QI examples, and signposting to resources available in the wider children and young people (CYP) epilepsy care system
- adapt QI priorities in line with new evidence based practice and guidance.

Epilepsy12 engaged with stakeholders to identify priority areas of care and agree five Health Improvement Goals to align with these.

- 1. Increase the proportion of children receiving input from an epilepsy specialist nurse by 5% per year; from 76% in Cohort 3 to 91% in Cohort 6.
- 2. For children with complex epilepsy, increase the proportion receiving input from a tertiary specialist by 5% per year; from 69% in Cohort 3 to 84% in Cohort 6.
- 3. Increase the proportion of children receiving all core elements for care planning by 5% per year; from 75% in Cohort 3 to 905 in Cohort 6.
- 4. Increase the proportion of Health Boards and Trusts using structured transition resources by 5% per year; from 62% in Cohort 3 to 77% in Cohort 6.
- 5. Increase the number of Health Boards and trusts screening children with epilepsy for mental health disorders by 5%; from 19% in Cohort 3 to 34% in Cohort 6.
