This is the second module of a five-part course aimed specifically at clinical leads and clinical directors. The programme and topics are based upon what clinical leads have told us they need - and which are not readily available within their own trusts or networks. Each of the five modules brings together paediatricians in similar roles to foster peer support, facilitated by expert topic presentations and sharing of practice examples.

This course aims to help you manage a paediatric clinical directorate and understand how to work with stakeholders to identify and support service development through budget allocation and business planning.

## **Course leads**

Dr Lisa Kauffmann FRCPH is a community paediatrician with an interest in palliative medicine. She has been involved in medical management for many years, and is currently Associate Clinical Head of Division for integrated community children's services at Manchester University Hospitals NHSFT. She played a key role in the design and implementation of the 'Making it Better' project to redesign maternity and paediatric services in the area. Lisa has extensive experience in clinical governance, service development and medical performance management, and was the clinical governance lead for the Greater Manchester paediatric network. She currently chairs the Greater Manchester children's palliative care network Lisa's other passion is in supporting clinicians to improve their communications skills and she is a qualified communication skills trainer, delivering courses across the NHS and for the RCPCH.

Sue Eardley joined RCPCH as Head of Health Policy in January 2011 and now leads the Invited Reviews programme for the College. Sue originally trained as an engineer /project manager in the oil and gas industry but changed career when the first of her three children arrived. Sue spent 13 years as a non-executive and then Chairman of an acute hospital trust in south London, alongside a range of voluntary activities including national and local involvement in user representation and as a Council member of the NHS Confederation. Sue led groups contributing both management and user input to the DH England Maternity National Service Framework and chaired her local MSLC for four years. Before joining the RCPCH Sue spent six years full time

heading up the Children and maternity strategy team at the Healthcare Commission and then CQC, overseeing strategy, design and delivery of all inspections and reviews in England of maternity, child health and safeguarding.
