

## **RCPCH Privacy Notice – Survey for overseas members on the impact of climate change on health**

The RCPCH Climate Change Working Group invites members based outside of the UK to complete a voluntary survey. The purpose of this survey is to highlight the impact of climate change on children's health from the perspective of healthcare workers from around the world. We plan to use the findings to support advocacy for action on the climate emergency and to share experiences with other child health professionals. We will combine the results of the survey into a report and will invite some respondents to contribute to a blog or podcast.

### **Why do we collect this information?**

The purpose of this survey is to understand the impact of climate change on children's health from the perspective of healthcare workers around the world.

This survey is voluntary and any data that is collected will be used where it is in our legitimate interest to inform and improve our position of support in the above areas.

By providing your contact details within the survey, you are consenting to us being able to contact you in relation to the answers you have provided. If you have provided the contact details of a third party, you must have consent to do this and they should be provided with a copy of this privacy notice.

### **Who might we share your information with?**

We will not share your personal data with anyone outside of RCPCH.

### **How long do we hold your information for?**

If you have provided your email address, we will keep this for as long as you consent to us contacting you. All other data will be kept until it is no longer required for our survey purpose.

### **Transferring information outside of the UK**

To provide some products and services we, or our data processors, may transfer and process information in countries outside of the UK. Some of these countries, such as those in the EEA, will have an officially recognised equivalent level of protection to the UK (adequacy decision). A

Where there is no adequacy decision, we will take all reasonable steps necessary to ensure that your information is protected by having in place a recognised safeguard with our partners and suppliers, such as regulatory approved Standard Contractual Clauses, Binding Corporate Rules or Codes of Conduct.
